Course Description

The task of behavioural neuroscience is to explain behaviour in terms of the activities of the brain. This course explores a wide variety of topics that may include the neural basis of learning, memory, sensation, and thinking, as well as behavioural and neurodegenerative disorders that arise from nervous system malfunction.

There will be 4 quizzes spread throughout the course worth 10% of your final grade. The quizzes will test you on the lecture material that has been covered since the last assessment, and are designed to keep you up to date with the course material. Quizzes will be written at the beginning of lecture, and will consist of approximately 3-4 short answer questions. Please ensure that you have a writing utensil with you at the beginning of each class.

There are three exams for this course; the two midterms will consist of multiple-choice questions. Questions can be drawn from lecture material and the assigned textbook chapters. Midterm #1 will be held on February 8th and is worth 25% of your final grade. Midterm #2 is scheduled for March 15th and will also be worth 25% of your final grade. Midterm #2 will NOT be cumulative. The final exam will be scheduled by the registrar and is worth 30% of your final grade, it will include multiple-choice and short answer questions; the final exam will NOT be cumulative.

During online course delivery:

Quiz assessments will be posted on D2L 30 minutes before the end of class (at 1:15PM) on the day of each quiz, and will be due 24 hours after posting. Students will be allotted 30 minutes to complete the quiz after they have started the assessment. Quiz content will still consist of 3-4 short answer questions and are designed to keep you up to date with the course material.

Midterms will be delivered as a timed assessment available on D2L at the beginning of class on the date of each midterm (February 8th, March 15th if online delivery is extended). Midterms will be available for

24 hours. When you access the assessment, you will have the length of the class (75 minutes) to complete and submit it. The assessment will consist of multiple-choice questions.

For both quizzes and midterms, If you experience and issue that affects your ability to complete the assessment, which can include (but is not limited to) issues with technology, caregiving responsibilities, or distractions within your test-taking environment, you will need to contact your instructor as soon as possible to arrange an alternate or (in the case of technical issues) extended time to write the assessment.

Quizzes and the short answer questions on the final exam will be graded using a similar format. Half marks will be given if it is clear that you know the general answer, but have omitted specific details or scientific terms. Full marks will be given to those that include specifics, and employ the correct terminology and concepts. Unless specified by your instructor, no books, notes, computers, calculators, or cellular phones will be allowed during exam/quiz writing.

The written assignment should be two pages in length (not including the reference section or title page) and formatted according to APA guidelines, it is due by 11:00 pm on March 24th (handed in via the assignment dropbox in D2L) and is worth 10% of your final grade. Your goal is to find and read a current news article describing research about the brain, and compare it to the original source, as well as relate it back to our discussion of brain and behaviour in the classroom. Further details regarding the assignment will be provided in class and posted on D2L. Late papers will be penalized 10% per day, unless an exception is made by your instructor.

Course Credits for Research Participation (Max 2% of final grade)

Students in many psychology courses are eligible to participate in Departmentally approved research and earn credits toward their final grades. A maximum of two credits (2%) per course, including this course, may be applied to the student's final grade. Students earn 0.5% (0.5 credits) for each full 30 minutes of participation. The demand for timeslots may exceed the supply in a given term. Thus, students are not guaranteed that there will be enough studies available to them to meet their credit requirements. Students should seek studies early in the term and should frequently check for open timeslots. Students can create an account and participate in Departmentally approved research studies at http://ucalgary.sona-systems.com. The last day to participate in studies and to assign or reassign earned credits to courses is Tuesday, April 12, 2022.

Supporting Documentation

Absence From A Test/Exam

Makeup tests/exams are **NOT** an option without the approval of the instructor. Students who miss a test/exam have up to 48 hours to contact the instructor to ask for a makeup test/exam. It's the instructor's discretion if they will allow a make-up exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam. At the instructor's discretion, a makeup test/exam may differ significantly (in form and/or content) from a regularly scheduled test/exam. Once approved by the instructor a makeup test/exam must be written within 2 weeks of the missed test/exam on a day/time scheduled by the instructor. If a student cannot write their final exam on the date assigned by the Registrar's Office, they need to apply for a deferred exam https://www.ucalgary.ca/registrar/exams/deferred-exams.

Department of Psychology Criteria for Letter Grades

Psychology professors use the following criteria when assigning letter grades:

A+ grade: Exceptional Performance. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade.

A, A- Range: *Excellent Performance*. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance*. Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: Satisfactory Performance. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and

content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: Course standards not met. Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.
