Course Description

This course will provide an overview of the field of psychopathology, including a historical perspective, current classification and diagnostic systems as well as theory, research and treatment methods. Some of the topics covered will include anxiety and mood disorders, somatoform, schizophrenia and psychotic disorders as well as personality disorders. The format of the class will be primarily lectures and discussion, although video presentations will also be utilized. Discussion regarding attitudes towards mental disorders, as well as current mental health ethics and legislation in Canada will take place. A student successfully completing this course will gain an understanding of the major forms of mental disorders, as well as psychological theories, research and treatment related to these areas.

Course Format

This is an in-person class held on campus.

Assessment Methods

Movie assignment (25%): Due Monday, January 31, 2022: Students will select a movie from the list below, and write a brief review (a maximum of 2 double-spaced pages). Students will: 1) briefly summarize the plot, name the character(s) with mental illness, and identify the suspected disorder(s); 2) comment on how accurately the disorder(s) is/are depicted, highlighting correct and incorrect aspects of the portrayal; 3) identify biological, psychological and social factors present in the film that may have contributed to the development and/or maintenance of the disorder(s), or speculate on these if they are absent from the movie. Students may make other observations they feel are relevant. The completed assignment is to be submitted to the designated D2L Dropbox on or before Monday, January 31, 2022, 11:59pm. Without instructor approval, late assignments will be penalized 10% per day, including weekends. Assignments more than 6 days late will not be accepted without prior instructor approval.

Students may choose from the list of movies listed below. These were chosen as they reflect different disorders, so that you can choose the topic of your own interest. If you find other ways to access these films that may be free, do let me know and I will share it with other students.

Midterm (25%): February 17, 2022: The midterm will cover content from all lectures and assigned readings (Chapters 1- 8 and 19) up until the day of the midterm. Lectures may include content that is not found in the textbook, and similarly the textbook may include sections that are not covered in lectures. The midterm exam will consist of a combination of 50 multiple-choice questions, as well as 20 short answer questions (limited to a few words). Exams in this course are closed book. The use of resources, including class notes, the textbook, online resources, and calculators is prohibited during the exams in this course. Students may not communicate with others about course material or the exam either in person or electronically during exams.

There will be no lecture on the midterm day, as class time will be taken for the midterm.

This timed assessment will be available on D2L at the beginning of class time on Febtruary 17, 2022 at 3:30 pm, and will be available for 24 hours. When you access the midterm, you will have a total of 90 minutes to complete and submit it (the length of the class plus 15 minutes to allow for technological issues). If you experience an issue that affects your ability to complete the assessment, which can include (but is not limited to) issues with technology, caregiving responsibilities, or distractions within your test-taking environment, please contact your instructor as soon as possible to arrange an alternate or (in the case of technical issues) extended time to write the assessment. If you have a formal accommodation, this will also automatically be taken into account when you access the examination, and your time will be adjusted accordingly.

Assignment 2: Due March 21, 2022: This assignment will involve reading one of two case studies provided by the instructor and responding to a series of questions regarding the case study you choose. Evaluation will be based on quality and comprehensiveness of responses to questions and evidence of critical thinking. The case studies, questions, and more detailed information regarding this assignment will be posted on D2L on or before Monday, February 21, 2022. The completed assignment is to be submitted to the designated D2L Dropbox on or before Monday, March 21, 2022, 11:59pm. Without prior instructor approval, late assignments will be penalized 10% per day, including weekends. Assignments more than 6 days late will not be accepted without prior instructor approval.

Final exam (25%): Date and place assigned by Registrar: The final exam will cover content from all lectures and assigned readings (Chapters 9- 18) since the midterm; it is noncumulative. The final exam will consist of a combination of 50 multiple-choice questions, as well as 20 short answer questions (limited to a few words). Exams in this course are closed book. The use of resources, including class notes, the textbook, online resources, and calculators is prohibited during the exams in this course. Students may not communicate with others about course material or the exam either in person or electronically during exams.

Department of Psychology Criteria for Letter Grades

Psychology course instructors use the following criteria when assigning letter grades:

A+ grade: Exceptional Performance. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade. A, A- Range: Excellent Performance. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance*. Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: Satisfactory Performance. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: Course standards not met. Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.

Course Credits for Research Participation (Max 2% of final grade)

Students in most psychology courses are eligible to participate in Departmentally approved research and earn credits toward their final grades. A maximum of two credits (2%) per course, including this course, may be applied to the student's final grade. Students earn 0.5% (0.5 credits) for each full 30 minutes of participation. The demand for timeslots may exceed the supply in a given term. Thus, students are not guaranteed that there will be enough studies available to them to meet their credit requirements. Students should seek studies early in the term and should frequently check for open timeslots. The last day to participate in studies and to assign or reassign earned credits to courses is Tuesday, April 12, 2022.

A Statutory Declaration requires students to make a declaration in the presence of a Commissioner for Oaths (see <u>ucalgary.ca/registrar</u>). It demonstrates the importance of honest and accurate information provided and is a legally binding declaration. Several registered Commissioners for Oaths are available to students at no charge, on campus, see <u>ucalgary.ca/registrar</u>. Falsification of any supporting documentation will be taken very seriously and may result in disciplinary action through the Academic Discipline regulations or the Student Non-Academic Misconduct policy.

Absence From A Test/Exam

Makeup tests/exams are **NOT** an option without the approval of the instructor. Students who miss a test/exam have up to 48 hours to contact the instructor to ask for a makeup test/exam. It's the instructor's discretion if they will allow a make-up exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam. At the instructor's discretion, a makeup test/exam may differ significantly (in form and/or content) from a regularly scheduled test/exam. Once approved by the instructor a makeup test/exam must be written within 2 weeks of the missed test/exam on a day/time scheduled by the instructor. If a student cannot

write their final exam on the date assigned by the Registrar's Office, they need to apply for a deferred exam https://www.ucalgary.ca/registrar/exams/deferred-exams.
