Course Description:

Through lectures and student presentations, this course will provide students an introduction to Psychopharmacology.

Prerequisites

Permission of Clinical Psychology Graduate Program.

Required Text

No text is required.

Assessment Methods

[Credit/Non-Credit course. Students are required to attend classes, design and deliver presentations, participate in class discussions, and complete peer-evaluations of presentations in order to receive credit for this course. Presentations will be assessed by the instructor as well as peer-evaluation by the other students.

Student Presentation: Students will work in pairs or, individually if warranted, to prepare and present a 60-minute seminar/lecture that provides background and current knowledge regarding use of medications/drugs for the treatment of a psychological/neurological disorder, or specific categories of drugs of abuse (eg. cannabinoids, opioids, prescription drugs). Topics include, but are not limited to: addiction, anxiety disorders, attention-deficit disorder, Alzheimer disease (cognitive disorders), autism spectrum disorders, bipolar disorder, depression, epilepsy, Parkinson's disease (movement disorders), schizophrenia, and sleep disorders.

Students who miss a test/exam have up to 48 hours to contact the instructor to ask for a makeup test/exam. It's the instructor's discretion if they will allow a make-up exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam. At the instructor's discretion, a makeup test/exam may differ significantly (in form and/or content) from a regularly scheduled test/exam. Once approved by the instructor a makeup test/exam must be written within 2 weeks of the missed test/exam unless there are extenuating circumstances.
